Practice Overview

Angus, who was called to the Bar in 2009, is renowned for expertise in cases involving complex financial crime, serious organised crime, regulatory offending and terrorism. He is regularly instructed in complex multi-handed cases for both the prosecution and the defence. He has recently prosecuted an organised crime group involved in the importation of high purity cocaine with a street value of £42 million.

Angus was instructed in the prosecution of a defendant who planned to detonate an explosive device inside St James Hospital in Leeds. He has also prosecuted individuals for their role in disseminating terrorist propaganda.

Angus is a Grade 4 prosecutor on the General Crime, CPS Specialist Fraud and Serious Crime panels. He is also a Grade 3 prosecutor on the Terrorism panel and a Panel B advocate for the Serious Fraud Office.
