#### Crime

Zarreen was called to the Bar in 2017. She became a tenant of Exchange Chambers in January 2023 following the successful completion of her common law pupillage. She has been briefed to appear and advise on behalf of the prosecution and defence, in a broad range of matters including:

- Football Banning Orders

Zarreen also accepts instructions in motoring and vehicle crime, and has made successful arguments for Exceptional Hardship on behalf of clients facing disqualification for driving offences.

During her first six months of pupillage, Zarreen observed and provided assistance on a wide range of criminal cases, including drugs conspiracies, robbery, section 18 assault, voyeurism and child cruelty. She also has experience in appellate work having been instructed and assisted in appeals in the Crown Court and the Court of Appeal.

She also volunteered at a Legal Aid centre in Accra, Ghana.

#### Cases

#### R v Singh

Zarreen secured an acquittal with a unanimous verdict for a defendant charged with three counts of sexual assault.

#### R v BK

Zarreen secured a 9 month referral order for her 15 year old client who was charged with a multi-handed robbery.
